Staff in the Urg station was laughing at me & smiling. Angie Rodriguez was charge nurse that day and blatantly asked me if I am accusing people of hiding my eye glass. I responded yes. Then she commanded me to just start doing my work and my glass will appear somehow. I was upset & refused to obey her until I found my glasses. (near) Heloise who just came out from the pt room pointed that she saw a glass in one of the cassette of the med cart mixed in with the syringes.

8/15/04 - Big Commotion & confrontation started. Petrus for night shift accused all the witnesses from last year having him & paid by ASHC. I spoke with him calmly since he might not know I am one of the witnesses I did not lie. He was more louder this time in my face & calling me a liar & so on & so forth. Same day numerous calls by some union members were made until they can get somebody to meet with them. Hope RW met with 4/19/04 -
